

# Adopt-A-Family FAQs



## How will Families receive their gift cards through the program?

Bringing Hope Home will purchase electronic gift cards with all funds raised by our donors and will provide the gift cards to all Families electronically through their email. If a Family does not have an email address, their electronic gift cards will be sent to their referring social worker at their treatment center/hospital so that the social worker can print the gift card and provide it to the Family at their next appointment or treatment. We feel that this is the safest way to provide the gift cards to our Families this year.

## How many gift cards will each Family receive and what dollar amount?

For each Family that BHH is supporting through the Adopt-A-Family Program, each member of the Family will receive \$100 in gift cards per person. So a Family of 3, for example, will receive \$300 in total gift cards.

## What will Families use their gift cards for?

Families will use their gift cards to purchase gifts for their own family members, which could include clothing, toys for children, shoes, small household and personal items, and other items the Family needs. Families may also use their gift cards to purchase a holiday meal for their Family.

## How do I know what to set my fundraising page goal to?

You can set your fundraising goal to whatever you would like! To help you set your goal, please note that each Family member will receive \$100 in electronic gift cards through the AAF Program. So if you set your fundraising goal to \$600 and meet your goal, you will be supporting 6 Family members (i.e. one Family of 6 people, two Families of 3 people, etc.)

## What if I surpass my fundraising goal and raise more money?

If you surpass your fundraising goal, BHH will use all additional funds as needed to support Families in need through our Light of Hope Family Grant or to purchase additional gift cards that will be used throughout the year to provide grocery and gas assistance to our Families. Any donations made over your goal will further support Families in need.

### Can supporters only donate to the AAF Program online?

No, BHH is accepting donations by check as well. Checks should be written out to “Bringing Hope Home” and mailed to our office at 641 Swedesford Rd. Malvern, PA 19355. In the memo section of your check, please write “Adopt-A-Family Gift Cards.”

### When is the last day that my family and friends can donate on my fundraising page?

All donation pages will remain open until the end of 2021.

### Are all donations tax deductible?

Yes, all donations made by you, your company, and those who donate towards your page are all 100% tax deductible.

### How will I get a receipt for my tax-deductible donation?

For any donors who make their contribution online, they will receive an automated email from BHH containing their receipt for tax purposes. Please hold onto your receipt for your tax records. If you mail a check to the BHH office, you will receive a paper receipt in the mail.

### What if my company matches charitable donations?

If your company matches charitable donations, please consider submitting a request for a company match to your employer, to further assist local Families with cancer. Bringing Hope Home’s EIN is 26-1222985.
